Dear CEA board members,

I am particularly keen on having a representative and qualified Community Advisory Committee. I read with concern that, in no part of the timeline is there a time to discuss the necessary qualifications for the members of the CAC. In order to be an effective advisory committee, there needs to be a diverse skill set, community outreach, marketing skills, regulatory skills, technical skills, etc. With these diverse skills, the CAC would be a valuable resource. Having been in a situation of creating new functions, I found that setting qualifications is not a trivial task.

The second task is, *CEA Board Approve Initial CAC Workplan & Meeting Schedule*. I worked for a company that employed the concept, "Management by Objectives" (MBO). What this meant that a division was given an objective, the management broke down those objectives and gave objectives to departments ... and on down to individuals. Everyone meeting their objective was key to the feeling of truly being a part of something bigger than one's self. This company was one of the most successful company of its time. If you mean by "workplan" objectives, following the idea of MBO, I have little doubt that the CAC will be successful in giving needed and timely advice to the CEA Board. Please consider this when setting the objectives of the CAC.

Tying these two together means that the objectives of the CAC must come before the setting of qualifications. Another point for consideration.
